# **ACADEMIC LEADERSHIP**

# Director, Charles Phelps Taft Research Center, January 2019-present University of Cincinnati

The Center is a hub for interdisciplinary discussion and innovation, offering a wide array of university and public humanities programs and opportunities designed to bring people from diverse backgrounds together across the university and the community at large. The Center's ultimate goal is to provide an essential platform to allow deep and diverse discussions and learnings about some of today's most vital and perplexing issues. The Center's transformative work promotes research on humanity across time, languages, and cultures. From scientific to literary research, from studies of identity and society to logic and ethics, student and faculty research provide tools for advances in humanity as well as ways to rethink humanism itself. The Center hosts a series of distinguished visiting lecturers, as well as its own faculty scholars,

who engage in a range of issues that often extend beyond the traditional ambit of the humanities and address issues of both local and global importance. The Center also offers a range of award and fellowship programs such as the Center Faculty Fellows program, Taft research seminars (funding for faculty-initiated interdisciplinary courses), awards and fellowships for undergraduate and graduate students who are conducting original research, and funding for departments to enrich their students' experiences.

# Key Accomplishments and Innovative Work:

- Raised an additional \$1.1 million in fiscal year 2021 and increased the permanent annual budget from \$1.4 million (FY19) to \$1.9 million (FY21). Also secured an additional significant emergency fund grant for the College of Arts and Sciences for Fall 2020 & Spring 2021.
- Created and collaborated with Cincinnati's Mercantile Library, "a gathering place for readers, writers and thinkers," to present an ongoing series of open forums and dialogues on important community issues. The inaugural sold-out forum: "Climate Change/Cincinnati" was a three-part series focusing on climate change and how it affects Greater Cincinnati and the community, and featured local, regional and national experts.
- Co-sponsored the Universities Studying Slavery ("USS") Consortium's 2019 annual conference: "The Academy's Original Sin", co-hosted with Xavier University.
- Actualized concrete goals to increase diversity of the hiring of Post-Doctoral Fellows and appointment of Center Fellows.
- Collaborated on humanities and social science research initiatives with university offices
  focused on the President's Next Lives Here Strategic Direction, particularly the President's
  Urban Futures initiative, which focuses on community outreach, social justice, and research
  innovation in the Cincinnati metropolitan area. Examples: A.I. and the Future of Work
  forum, Storytelling and Social Justice In A "Post-Truth" Era Collab, and the Teaching Tarell
  Alvin McCraney forum.
- Established the Taft Director's Advisory Committee to create a more collaborative environment and better execution on the strategic planning of Center programming, award programs, budget expenditures and requests, research groups, and Center activities.
- Lead and guided the 18-member Taft Faculty Executive Board to increase demand for and competitiveness of Taft awards and fellowships.
- Established annual themes at the Center. 2020-21 Annual Theme: Disrupting Research/Researching Disruption. 2021-22 Annual Theme: Racism & Anti-racism.

- Raised additional off-cycle funds and developed new event and award programs to respond to current issues and support faculty and students from underrepresented backgrounds.
- Completed an overhaul of the Center's accounting system, creating more efficiency and transparency.

#### Provost Fellow, 2017-2018

Appointed Provost Fellow, reported to the Vice Provost for Undergraduate Studies, to assist with the University's ten-year reaccreditation review by the Higher Learning Commission. Main responsibility was for assessment and reaccreditation planning of degree programs not requiring professional accreditation, including approximately 65 undergraduate and 22 graduate degree programs in 21 departments in the College of Arts and Sciences. The Higher Learning Commission's Final Report noted that "UC's engagement with student learning outcomes is a national model for large research universities."

# Key Accomplishments and Innovative Work:

- Lead facilitator of program assessment design and planning. Over 90 degree program assessment plans were submitted in Spring 2018.
- Developed a permanent, sustainable annual assessment reporting infrastructure in the College of Arts & Sciences, where departments now submit annual assessment reports to the College and Office of the Provost.
- Collaborated with the Director of the University's Center for the Enhancement of Teaching and Learning, graduate program directors, and department heads to create sustainable program assessment tools resulting in 95% compliance of all degree programs.
- Served on two university-wide Higher Learning Commission Assurance Argument committees. Co-authored Criterion Three: Teaching and Learning: Quality, Resources and Support and Criterion Four: Teaching and Learning: Evaluation and Assessment.
- Served as a member of the Office of the Provost Academic Committee. Reviewed new degree and certificate program proposals and conferred on changes in General Education requirements.
- Strategically arranged for 60 College of Arts and Sciences faculty members to attend the Higher Learning Commission Reviewers' meeting focused on Assurance Argument Criterion Three and Four.

# Head, Department of Women's, Gender, and Sexuality Studies (WGSS) August 2015-December 2018

The Department of Women's, Gender, and Sexuality Studies is an interdisciplinary department comprised of twelve core tenure-track and research faculty and over 100 affiliates with departmental homes across campus. WGSS offers a BA, undergraduate minor, stand-alone MA, LGBTQ studies undergraduate certificate, 4+1 BA/MA, graduate certificate, and several dual degree graduate programs including: MA/JD, MA/MPH, MA/MA with French and German Studies, and MA/PhD with English, Sociology, Philosophy, and Political Science. As Head, I had 37 core, adjunct faculty, staff and graduate assistant direct reports.

# Key Accomplishments and Innovative Work:

- Oversaw WGSS curriculum and course orders and collaborated with units within the College of Arts and Sciences and across colleges to promote interdisciplinary degree programs, courses, and research and teaching initiatives.
- More than tripled undergraduate majors and minors, from 14 majors and 16 minors in Fall 2015 to 45 majors and 53 minors in Fall 2018.
- Facilitated the college creation of a new Social Justice Certificate program, housed in and managed by WGSS (now a BA program, as of 2020).
- Negotiated new directorship of and revival of Latin American, Caribbean, and Latinx Studies BA program, initially housed in and managed by WGSS.
- Established four new dual degree MA/PhD programs between WGSS (MA) and Political Science (PhD), Sociology (PhD), English (PhD), and Philosophy (PhD) and two new dual degree MA/MA programs between WGSS and French and Spanish.
- Increased student credit hours per core faculty between 2015-2018. In Fall 2018 WGSS had the second highest teaching efficiency rate in the College of Arts & Sciences.
- Added three new full-time tenure-track faculty members, including:
  - A successful proposal for the competitive Office of the Provost Urban Futures tenure line resulting in the hire of an assistant professor whose work focuses on black queer urban and environmental histories.

- Negotiated a joint research faculty line between the University and Cincinnati Children's Hospital. Hired an Associate Research Professor whose work focuses on the ethical, legal and social implications of genetic testing and reproductive technologies and policies.
- o Brought in a scholar at an advanced assistant professor level whose work concentrates on gender, sexuality and Jewishness in German film.
- Oversaw the tenure and promotion process and the annual performance review process in the department. Worked with and mentored four department members who received promotions and/or tenure during my term as Head.
- Successfully mentored and nominated colleagues and students for numerous awards, fellowships, and applications for tenure and/or promotion.
- Oversaw the *Friends of WGSS* Board, managed the endowment, and increased diversity and scope of targeted donors. Closely collaborated with the UC Foundation to increase outreach and develop new fundraising opportunities.
- Raised significant discretionary funds for graduate assistantships (including a single \$50,000 gift).
